The University of Engineering and Technology Mardan, KPK has received an allocation from the Public Fund in PKR/Foreign Currency towards the cost of the project titled "Establishment and Upgrading of Core Engineering Departments at UET Mardan" and "F/S-And Provision for Upgradation Of UET Sub Campus Mardan To The Level Of University" It is intended that part of the proceeds of this allocated fund will be applied to eligible payments under the contract "Networking for the Academic Block, Boys Hostel, Girls Hostel and Staff Hostel in the project titled "Establishment and Upgrading of Core Engineering Departments at UET Mardan".

- The University of Engineering and Technology Mardan, KPK, invites sealed bids on lot basis from eligible firms
 or company registered with relevant govt. authority. A foreign bidder is entitled to bid only in a joint venture
 with a Pakistani supplier/agent in accordance with the provisions of PEC bye-laws. Bidders may obtain further
 information from, inspect at and acquire the Bidding Documents from the Purchase Section, UET Mardan
 from 10.00 am to 04.00 pm.
- 2. A complete set of Bidding Documents may be purchased by an interested bidder on submission of a written application to the above office and upon payment of a non-refundable fee of Rs.2500.
- 3. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the Khyber Pakhtunkhwa Public Procurement Act and its Rules made thereunder which also conform to the requirements of the World Bank Standard Bidding Documents: Procurement of Goods for National Competitive Bidding, Pakistan, Part One.
- 4. All bids must be accompanied by a Bid Security equal to 2% of the Bid amount and must be delivered to Purchase Section, UET Mardan from 10.00 am to 04.00 pm on or before September 16, 2021, 10:00 am. Bids will be opened at 10:30 am on the same day, in the presence of bidders' representatives who choose to attend at the same address. The Bid security amount shall not be disclosed to any person.
