

A bid shall be rejected if Applicant's technical qualification thresholds are no longer met at the time of bidding.

#### **OTHER FACTORS**

Only Applicant firms/ companies / contractors that have been technically qualified under this procedure shall be eligible for opening of the financial bid. If a firm submits more than one bid, all bids including that bidder will be rejected. This rule will not apply in respect of bids which include specialist sub-contractors who are used by more than one Bidder.

The UET Mardan reserves the right to: -

- a) Amend the scope and value of contract to be bid, in which event the Bidder (s) will only bid among those technically qualified Bidders who meet the requirements of the contract as amended.
- b) Reject or accept any application; and
